3. OPI is committed to ensuring our packaging has minimal impact on the environment. We work with our suppliers to design packaging according to the following principles:

4. OPI is committed to reducing the variety of plastics employed and to use plastics of similar composition.
5. OPI has a policy of recycling waste material generated in the manufacturing process. Our strategy is to minimize all solid waste and to recycle or recover the energy whenever possible.

Reduce, or prevent the environmental impact of our products and packaging in their design, manufacture, distribution, and disposal whenever possible. We support the sustainable use of resources and actively encourage reuse, recycling, and energy extraction.

Meet or exceed the requirements of all environmental laws and regulations. We use environmentally sound practices, even in the absence of government standards. We cooperate with governments in analyzing environmental issues.
